

**Edmodo** is quickly becoming one of the most popular technology tools used by the West Orange High School faculty. Appearing to the student much like facebook, edmodo gives students the feel of a social networking platform, while being completely controlled by the teacher in a secure, private web area. It functions as a webpage, blogspace, and interactive tool for collaboration, all in one. Students and staff members alike can work on group projects, upload documents and files of any kind to the class -- as a group -- or privately to the teacher. Students can workshop, peer edit, blog, view video, maintain document libraries, receive class assignments, updates -- all visible and controlled by the teacher extraordinary flexibility and control.

This class will instruct teachers how to: set up teacher and student accounts, create small learning groups, create assignments, calendar posts, assignments, alerts, how to receive notifications of postings by text message or email, set up polls, embed YouTube video, use blogging capacities, and show ways that teachers have been successfully incorporating this platform in a variety of lesson plans.

#### Guitar Club Proposal

The guitar club, as you know, is a club that has become a tradition at The Redwood School. We meet two times a week before school, 7:45-8:25. This year we will start October 11 and go at least through April 5.

The students learn how to play the guitar. We have foot stools and guitars for the students to use while they are in school. Music is distributed to them. They may take the music home to practice on a guitar if they have one at home. During class the music is projected onto a screen from the computer.

The students learn to perform about 5-10 simple melodies. They also learn how to play about 5-10 chords and are able to sing and accompany themselves on the guitar for about 5-10 songs. We also learn about and listen to recordings and see videos of well known guitarists of various styles including classical guitar and jazz guitar.

At the end of guitar club we have an evening performance that lasts about 45 minutes where the students perform about 5-10 selections Parents of the students attend the concert. Other guitarists and students from the community are invited to attend and also perform. Each student receives a certificate displaying his or her achievement.

In the past I have received a small stipend for running the club. I think it was \$800.00 for the last few years.

#### Microsoft Word 2007

Participants will be introduced to new features of the Word 2007 interface and will practice using tools available to create, save and print professional Word documents. Participants will be able to apply text formatting; use bullets, numbering, and outlines; use editing and proofing tools; determine paragraph settings; work with tables; define print layout including headers and footers and incorporate graphics. Participants will also practice using intermediate level tools available to create, save and print professional Word documents. Topics covered include applying and creating document styles; using collaboration tools; working with columns; inserting a table of contents and other reference tools; working with graphics and creating a mail merge.

#### Microsoft Excel 2007

Participants will be introduced to new features of the Excel 2007 interface and practice using tools available to create, save and print meaningful Excel worksheets. The Social Studies Department is committed to continuing our efforts to insure an inclusive K-12 curriculum with a particular concentration on satisfying the Amistad mandate. The entire elementary staff will be taking part in an on-going and free professional development program with the New Jersey Department of Education's Amistad Commission throughout the 2011-2012 SY. Stephanie Wilson, Executive Director of the Amistad Commission will be conducting the professional development on site.

Last year, representatives from all seven elementary, the three middle schools and the high school engaged in a three day professional development workshop with Dr. Molefi Asante and Dr. Ama Amamaza of the African American History Department at Temple University. The representatives from each school turn keyed the essential concepts and instructional materials with their respective colleagues at their school and found the sessions inspiring and enlightening.

We respectfully request that the Board fund a second cohort of teachers to attend the trainings this academic school year, SY 2011-2012. In light of the K-5 Social Studies curriculum being rewritten, I would like to send representatives from the curriculum team to ascertain how the Amistad curriculum can be further infused into the new K-5 Social Studies curriculum.

I propose sending a total of 8 teachers, 1 Library Media Specialists and 1 Reading Specialists to the November 17<sup>th</sup>, January 24<sup>th</sup> and March 19<sup>th</sup> training sessions at Kean University.

The cost is 900.00 per person \* 10 people = 9,000.00 total.

I have attached a description of the program and the contract from the Rahway Public Schools, the sponsor of the program. We appreciate your consideration.

# ASANTE AFRICAN AMERICAN HISTORY CURRICULUM INFUSION TRAINING MODEL

## Description

This is a research driven, African American history workshop model for K-12 school teachers, based on centering students culturally in classical and historical traditions. It is designed to teach teachers the best methods for centering their students. It was developed by Dr. Molefi Kete Asante with the specific intention of training teachers to reach African American children but has been applied by teachers with Latino children and Asian children as well. In fact, the Afrocentric idea seeks to enthrone the concept of infusing content with ideas, themes, and subject matter that attaches the child to the subject.

Dr. Asante is the author of 65 books on many aspects of culture, language, and education, including the most used African American history high school text, *African American History: A Journey of Liberation*. His workshops have been conducted in New York, Los Angeles, Birmingham, Gary, Indiana, Baltimore, Camden, and the Virgin Islands as well as many smaller school districts. Dr. Asante is responsible for writing the Philadelphia District's mandatory course in African American History. Professor Asante is considered one of the most distinguished contemporary African American educators. He maintains that the principal reason students do not achieve is because they are culturally dislocated, not culturally deprived. His method teaches teachers how to bring students inside the subject.

Culture is curriculum and curriculum is culture. This means that students will model what they see and hear in the entire school context. The AACIM ultimately seeks the participation of all school staff, administrators, teachers, and cafeteria employees. All are a part of the plan to educate the children and bring about greater achievement academically and behaviorally.

The Afrocentric infusion grounds students in the classical African cultures, ancient Egypt, Nubia, Ethiopia, Ghana, Mali, and Songhay, in order to support the African American emphasis on centered-location. Most students, black, white, Latino, or Asian, have little or no knowledge about the origin of African American history. Furthermore, the vast majority of African American students are disconnected from a historical context that demands of them attention to detail, value, dignity, and achievement. Relocating students within the context of culture is the teacher's chief method of making a difference and creating discipline in the classroom. This model of training the teachers work because it is grounded in theory and demonstrates for teachers how to attach the students to the subject.
