



Per our recent conversation, this letter is confirmation that our firm has been retained to conduct a traffic study and assessment for the referenced matter. We are pleased to provide this proposal for professional traffic engineering services in connection with the above noted project. By way of background, Joseph Staigar Engineering, LLC is a civil engineering consulting firm, specializing in the areas of traffic and transportation engineering. As discussed, the intent of these services is to represent you in the safety concerns related to the referenced application. We will concentrate on the areas of traffic impact assessment, and the potential detrimental effects that the proposal may have on adjacent roadways, and particularly for safety of the schoolchildren at St. Cloud's School.



Agreement between Asia Society and West Orange Public Schools

Congratulations on your continuing status as a member of the Hanban – Asia Society Confucius Classrooms Network, an international partnership between Hanban and Asia Society dedicated to building the field of Chinese language teaching and learning in American schools.

As a member of this Network, we recognize your strong potential to lead the development of the field of Chinese teaching and learning and international education into the future. Your program is one of the anchors for the development of our Network of 100 Chinese language programs in US schools over a three-year period.

As you are aware from the RFP, you were selected based on a consideration of your achievements and potential in the following areas: (1) curriculum and instruction; (2) integration and culture; (3) leadership; and (4) partnerships.

Your continuing membership in the Network is contingent upon your signing and submission of this agreement.

1. Cash Award. As part of participation in the program, Asia Society is pleased to offer West Orange Public Schools a cash award in the amount of \$20000 for the period December 1, 2010 to August 31, 2011 (referred to as Year Two) to implement the project described in your Year 2 Proposal. West Orange Public Schools will receive an additional \$30000 to support the salary of a new Chinese language teacher, and a travel allowance of \$1,000, specifically to cover your travel cost for (1) one representative from your Confucius Classroom to attend the National Chinese Language Conference; and (2) one representative from your Confucius Classroom to attend the Asia Society Confucius Classrooms Teachers Institute. In total, Asia Society will award West Orange Public Schools \$51,000.

Provided that both parties are satisfied with progress on the project and pending additional funding, an additional cash award will be provided for the period September 1, 2011 to August 31, 2012 (referred to as Year Three).

The amounts of these awards will be based on a proposed annual budget for relevant projects submitted to Asia Society for review and approval.



Any unexpended portion of the annual cash award may be used in the following program year. If any portion of the awards remains unexpended by August 31, 2012, or in Asia Society's judgment has not been duly committed to the development or fulfillment of the proposed projects, **West Orange Public Schools** will return such portion to Asia Society, unless Asia Society otherwise agrees or directs in writing.

- 2. Support Provided to Member Institutions. Your package of support as a member of the Hanban Asia Society Confucius Classrooms Network includes the following (subject to Hanban approval and availability of funds):
 - 1. Authorization to use the title "Confucius Classroom"
 - 2. Assistance in identifying and developing a partnership with a school in China
 - 3. The opportunity to receive an annual program grant based on the school's program and budget proposal.
 - 4. Up to 3 placements for school representatives each year to participate in an exchange program in China, e.g. the Chinese Bridge program
 - 5. 3 or more scholarships for summer camp for students who are learning Chinese in a summer camp designated by Asia Society
 - 6. Up to 3 scholarships for teachers to travel to China for professional development in a program designated by Asia Society
 - 7. The opportunity to apply for one or more guest Chinese teacher(s) to start or expand Chinese language classes or provide cultural enrichment activities
 - 8. Participation in professional development with other high quality programs from across the nation organized by Asia Society
 - 9. Organizational membership in Asia Society's Partnership for Global Learning, a network of individuals and institutions aimed at increasing students' global competency.



- 10. Attendance at our annual Confucius Classrooms Network Meeting and the National Chinese Language Conference (Asia Society will cover the registration fee and the hotel expenses for one representative from your Confucius Classrooms)
- 11. The opportunity to receive up to 1,000 volumes of books, audio-visual, and multimedia materials and courseware, selected from Chinese language learning materials available through Hanban's online ordering system
- 3. Responsibilities of Member Institutions. As a member of the Hanban Asia Society Confucius Classrooms Network, West Orange Public Schools agrees to:
 - 1. Continue to improve the quality and scope of its Chinese program and make the program long-term
 - 2. Be willing to act as a model / assistance center for your region
 - 3. Partner with a school in China, including sending representatives to China (via the opportunities noted above), to enhance language and culture learning, as well as professional leadership and development
 - 4. Participate regularly in Asia Society's online community for the Confucius Classrooms Network and be willing to provide examples of best practices, student work, model lessons, and curricula that may be useful resources for the field
 - 5. Participate in Asia Society organized activities to develop and promote best practices in the field
 - 6. Submit a brief report to Asia Society annually that details (1) program size and growth; (2) partnership activities; professional development offered; (3) outreach to other schools or districts in the region and community activities; (4) plans and budget for the following year; and (5) actual expenses and use of funds
 - 7. Send at least one representative to the annual National Chinese Language Conference and the associated Confucius Classrooms Network Annual Meeting
 - 8. Be willing to receive exchange visitors from your Chinese partner school



4. Press and Media Activities. West Orange Public Schools agrees to use the name "Hanban – Asia Society Confucius Classrooms Network" when making official reference to the program.

5. Nature of the Agreement and Compliance

Status. Asia Society enters into this arrangement as a sponsor and supporter of efforts to develop the Confucius Classroom, but not as a partner or joint venturer. Neither Asia Society nor any trustee, officer, employee, or agent of Asia Society assumes any responsibility for how the Confucius Classroom is operated or how it conducts any activity.

Hanban and Asia Society reserve the right to terminate membership at any time for schools that do not meet the requirements of the program or adhere to the terms of the agreement.

Termination of the Agreement. Asia Society reserves the right to discontinue support for the development of the Confucius Classroom if Asia Society is not satisfied with the progress of this project. Notwithstanding any other provisions of this letter, in the event that the agreement is terminated, no amount of unpaid funds will be paid to **West Orange Public Schools.** In the event of a dispute concerning the meaning of any provision of this grant letter, it shall be construed in accordance with the laws of the State of New York (without regard to principles of conflicts of law).

Public Reports. Asia Society will include information about West Orange Public Schools's Confucius Classroom in its periodic public reports and may also refer to the school and Asia Society's involvement with the school in press releases. Asia Society will be provided by West Orange Public Schools with the opportunity to comment in advance on any proposed media release concerning Asia Society's involvement in any way with West Orange Public Schools and the development of the Confucius Classroom. West Orange Public Schools must obtain written permission of Asia Society for any proposed use of Asia Society's logo or other proprietary pictures, images, designs, or slogans.
