SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF WEST ORANGE, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY

AND

BOARD OF EDUCATION OF THE TOWNSHIP OF WEST ORANGE IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY,

PROVIDING FOR EXPANSION OF FACULTY AND ADMINISTRATIVE PARKING AND CONSTRUCTION OF A BUS LANE AT THE GREGORY ELEMENTARY SCHOOL IN AND FOR THE TOWNSHIP OF WEST ORANGE

SHARED SERVICES AGREEMENT

This SHARED SERVICES AGREEMENT (the "Agreement") shall be and hereby is entered, between the Township of West Orange, a municipality in the County of Essex and State of New Jersey whose address is 66 Main Street, West Orange, New Jersey 07052 (the "Township") and the Board of Education of the Township of West Orange, a school district and political subdivision in the County of Essex and State of New Jersey whose address is 179 Eagle Rock Avenue, West Orange, New Jersey 07052 (the "School District"), dated as of February _____, 2016.

WITNESSETH:

WHEREAS, the Township and School District (collectively referred to as the "Parties") have entered into various shared services and inter-local services agreements in the past, which assist in the improvements of facilities of the School District for school and municipal services;

WHEREAS, a shared services agreement is needed to effectuate improvements to the Gregory Elementary School, located at 301 Gregory Avenue, West Orange, New Jersey 07052 (the "Gregory School"), and the Township and the School District have determined that it is the most cost effective and in the best interests of the Township, the School District and the residents thereof for the Township and the School District to be jointly responsible for expanding the existing faculty and administrative parking at the Gregory School and designating a bus drop off lane on school property; and

WHEREAS, the Gregory School bus lane is currently located on a public street and there is substantial traffic congestion due to the limited amount of faculty and administrative parking available at the Gregory School; and

WHEREAS, the Township and School District agree that expansion of the existing faculty and administrative parking and construction of a bus lane in front of the Gregory School would be beneficial to the Township, the School District, and Township residents; and

WHEREAS, the Township and School District intend to improve the current parking situation at the Gregory School by expanding or causing the expansion of existing faculty and administrative parking and creation of a designated semi-circular bus drop off lane in front of the Gregory School, and the Township desires to assist the School District with the improvement of same (with such improvement being referred to hereinafter as the "Project"); and

WHEREAS, the Project cost is estimated to be \$400,000, which will be financed through bond obligations, as set forth in Township Bond Ordinance No. ______ (the "Bond Ordinance"), the terms of which shall be deemed to be applicable to this Agreement and incorporated herein; and

WHEREAS, the Township and the School District desire to set forth certain terms and conditions relating to the Project and payment therefor; and

WHEREAS, the Shared Services Act, <u>N.J.S.A.</u> 40A:65-1, et seq., authorizes and encourages local units, including municipalities and school districts, to enter into local contracts for services performed by local units in accordance with law for the purpose of reducing property taxes through reduction of expenses; and

WHEREAS, municipalities and school districts are expressly authorized to work together for the provision of recreational and educational related improvements pursuant to <u>N.J.S.A.</u> 40:48-2, <u>N.J.S.A.</u> 40:61-1, <u>N.J.S.A.</u> 40:61-5, <u>N.J.S.A.</u> 18A:20-22, and the Shared Services Act; and

WHEREAS, the Township approved the execution of this Agreement by resolution adopted on February ____, 2016, and the School District approved the execution of this Agreement by resolution adopted on February ____, 2016;

NOW, THEREFORE, the Parties hereto mutually agree as follows:

Section 1. The Township and the School District will act together in accordance with this Agreement to implement the Project for a total estimated cost of \$400,000.00, with the sum to be satisfied pursuant to the terms of the Bond Ordinance.

Section 2. The Township will, pursuant to the Bond Ordinance, make the funds available for implementation of the Project, and the Township shall be responsible for the implementation of the Project in accordance with the requirements of law.

Section 3. The Township shall be solely responsible for paying the amount of funds available pursuant the Bond Ordinance.

Section 4. The School District shall make the Gregory School property available for the improvements and implementation of the Project at reasonable times, and shall be responsible for overseeing timely completion of the Project. The School District shall be solely responsible for the design and approval of the architectural plans in accordance with applicable laws and regulations.

Section 5. Upon completion of the Project, the School District shall be responsible for the upkeep and maintenance of the Project and all improvements.

Section 6. The Township and the School District each hold each other harmless against any claims, demands, liabilities, damages, losses, costs, charges, and any and all expenses (including, but not limited to, reasonable attorneys' fees) that either may be incurred or to which the Parties may be subjected as a consequence directly or indirectly of any breach or nonperformance by either party of its obligations under this Agreement or by the willful or negligent act of either party in connection with its performance or nonperformance.

Section 7. The Township shall ensure that the contractor responsible for the Project submit proof of and maintain liability insurance in the amount of at least one million (\$1,000,000.00) dollars and shall name the Parties as additional insured.

Section 8. The Parties' rights and obligations under this Agreement shall not be assigned by either party without the written consent of the other.

Section 9. This Agreement shall remain in effect for a period of ten (10) years from the date of this Agreement.

Section 10. This Agreement shall not affect or impact any other existing rights, liabilities or obligations of the Township and/or School District, pursuant to State and federal law.

Section 11. This Agreement may not be amended or modified for any reason without the express prior written consent of the Parties hereto.

Section 12. In the event that any provision of this Agreement shall be held to be invalid or unenforceable by any court of competent jurisdiction, such holding shall not invalidate or render unenforceable any other provision hereof.

Section 13. This Agreement sets forth the entire understanding of the Parties hereto with respect to the transactions contemplated herein. No change or modification of this Agreement shall be valid unless the same is in writing, duly authorized and signed by all the Parties hereto.

Section 14. It is understood and agreed that nothing which is contained in this Agreement shall be construed as a waiver on the part of the Parties, or of any right which is not explicitly waived in this Agreement.

Section 15. This Agreement shall be governed by the laws of the State of New Jersey.
