School Meals

The Summer Meal Program will be ending on Friday, September 11, 2020 in accordance with the federal and state mandates. The district will continue grab-n-go breakfast and lunch pick-up on Monday, September 14, 2020 for the start of the school year. Meals will be available at no charge for all students and can be picked up at any elementary school in the district. For the convenience of parents, meals will be distributed on Mondays, Wednesdays and Fridays each week between the hours of 10am and 12pm. School Closings

Parents/guardians are notified by automated phone calls, text messages and emails. All parents/guardians should be registered for our School Messenger service. Notifications for school closings and delayed openings also appear on TV36/Verizon 45, major media TV outlets and on the district website.

Attendance Regulations and Student Daily Attendance

Student attendance is extremely important and directly related to achievement. We have attendance regulations for all WOHS students posted on our website and are included in the electronic Student Handbook. Students risk losing credit for courses if they exceed the number of acceptable absences. Students can also be denied credit in a course, if three or more "cuts" are accumulated. Our policy specifically states that a student may not exceed a total of 17 chargeable absences for a full course or 8 chargeable absences for a semester course. It is extremely important that students attend school regularly, submit notes explaining absences and keep documentation for all absences.

Health Examination and Immunization Requirements

All students are required to submit an updated "Health Physical Form." A Pupil Health Examination form can be found on the District website. Locate the WOHS page, click on *Health* tab then click on *Important Health Forms*. Kindly return the completed forms to our school nurses' office, room 1122. If medication is required, please attach the medication to the proper signed medical forms. It is important that all forms are returned on the first day that students return to school.

9th and 11th grade Family Life Education Curriculum

Parents/Guardians for 9th and 11th grade students should read the enclosed letter from Dr. Cascone and a course outline concerning the teaching of Family Life (Human Development), mandated by the State of New Jersey in 1983.
